

Whitewater ADVENTURE

Take on the mighty waters of the Lehigh River! We've partnered with **Pocono Whitewater** to provide our Scouts with a Whitewater Rafting Adventure this summer! With the Lehigh River located right on our Camp's doorstep, we have the *perfect* opportunity to offer scouts this Rafting experience at one of the best rates.



What will Scouts experience? *Scouts of all skill levels* will venture out onto the **Lehigh River**, guided by Pocono Whitewater river guides, and accompanied by Settlers Camp Staff. Depending on the water level, you'll paddle through **8 miles of Class 1, 2, or 3 whitewater rapids**, traveling for around **3-4 hours on the river!** Lunch options will be provided by Pocono Whitewater out on the River. This program is perfect for Scouts looking for an **alternative to our Trexler Rangers Program on Wednesday Afternoon.**

Schedule: Wednesday Afternoon-5pm. (Takes place during Trexler Rangers) Scouts attending this will need to leave their 10am Merit Badge Session slightly early to meet up with the departing Whitewater transportation bus. The staff will let them know when to leave. If any material is missed in that time, staff will work with scouts to cover the missed material.

Cost: \$35 per Scout (to be confirmed for 2020) -Trips can be purchased prior, or at the Trading Post during your stay at Camp.

What to bring: Swimsuit/Towel, the permission waiver (found below). You'll be on the water for most of the day, so keep in mind anything else you may bring is subject to loss/water damage.

Parental/Guardian Permission Waiver

The waiver below must be entirely filled out and brought to camp. If a Scout purchases a trip at the Trading Post, the Office must receive verbal permission/signature from the parent/guardian. If a Scout does not have the waiver, or receive a permission/signature, they will not be permitted to attend the whitewater trip.
